Baltic International Academy (Riga, Latvia), represented by the Chairman of the Senate Stanislav Buka, acting on the basis of the By-laws and the Non – profit joint stock company «Kh. Dosmukhamedov Atyrau University» (Atyrau, Kazakhstan) represented by its Chairman of the Board-Rector Idrissov Salamat Nurmukhanovich acting on the basis of the By-laws, both jointly referred to as the Parties,

WHEREAS the Parties:

acknowledge education to be a major factor in economic and social progress of the society and the state; appreciate the necessity to preserve and develop the traditions of international cooperation in educational sphere;

in an effort to contribute to development of education and science and strengthen their interconnection; and being aware that sharing experience, information, exchange of students and professors as well as mutual participation in various projects are of great importance for both Parties; have concluded this Agreement as follows:

SUBJECT OF THE AGREEMENT.

1.1. The Parties maintain and develop cooperation in the area of education and science by encouraging efficient operation of the system of higher and post graduate professional education, training of highly-qualified specialists with university education and scientific personnel with top qualifications, ensuring continuous professional development of employees as well as integration of the higher education and science.

1.2. The Parties acknowledge that international cooperation in the area of education and science, joint participation in discussing and solving the topical problems, exchange of educational, scientific and information technologies, of students and professors, creation of mutual educational programmes and courses, as well as shared use of intellectual and material resources available to the Parties represent the key area of activities that are mutually beneficial for the Parties to the Agreement.

1.3. The Parties express willingness to unite their efforts in achieving the goals set by this Agreement to the fullest degree and to establish partnership relations between the Parties.

1.4. The present Agreement sets the principal directions and forms of cooperation between the Parties being the basis for development and implementation of joint educational programmes as well as educational scientific and research, information and other projects. Implementation of specific joint programmes and projects shall be carried out on the basis of separate agreements.

2. AREAS OF COOPERATION.

2.1. Cooperation between the Parties shall be carried out in the following areas: Assistance in training the students as future highly-qualified specialists as well as high school scientific personnel:

 development and publishing of joint study materials, scientific and tutorial literature, guidance manuals, preparation of joint scientific monographs, popular science publications, articles, etc.;

- exchange of specialists, professors and members of academic and administrative staff within the framework of educational and scientific programmes share experience, carry out teaching activities, deliver lectures, participate in mutual programmes and projects, conferences, seminars, symposia and round tables, conduct research in the areas that are of particular mutual interest, organise secondment and studies for the Master's and Doctoral degree;
- ensuring the possibility to exchange students within the framework of educational and scientific
 programmes including coordinated comprehensive educational programmes with the purpose of
 undergoing training, upgrading qualifications, professional knowledge and enhancing competitive
 abilities on the labour market, participation in joint programmes and projects, as well as in the
 conferences, seminars, round tables and other events, carrying out research activities in the areas of
 mutual interest;

sharing experience of organisation and methods of conducting classes, applied educational technologies;

contributing to practical and on-the-job training arrangements for the students, Candidates for

Master's and Doctor's degree.

Further improvement and implementation of various forms and methods of integration of education and

conducting joint research in the areas of mutual interest as well as involving students, candidates for Master's and Doctor's degree in scientific and research activities in the focal areas of fundamental and applied scientific research;

implementation of common projects and programmes of training highly qualified specialists as well as joint participation both in national and international educational programmes and projects;

implementation of the common projects for professional upgrade of educational research and

administration staff of both higher educational establishments;

conducting and organisation of professional training courses and further vocational training courses, as well as scientific, scientific and practical and scientific and research seminars, conferences, symposia, round tables and other events both for the teaching and administrative staff and the students, candidates for Master's and Doctor's degree of the higher educational institution;

carrying out scientific-methodological management as well as further improvement of methodological support of the study process;

securing conditions for successful operation of educational complex to ensure continuous studies;

implementation of the common informational support and information exchange projects;

development of practical recommendations for the government authorities (including projects of legislative instruments) on the topical issues in education and science.

2.2. The list of cooperation areas may be supplemented and adjusted upon mutual agreement between the Parties.

3. FORMS OF COOPERATION.

3.1. Cooperation under the present Agreement can assume the following forms:

Formation of mutual work teams and expert groups, multidisciplinary teams for coordination of the activities and for development and implementation of the project solutions suggested within the framework of the present agreement;

Exchange of scientists, professors and experts on the themes arising in the course of cooperation,

arranging for mutual consultations;

Implementation of the common scientific, educational, scientific and research and design and

experimental programmes and projects;

Exchange of information, documentation, literature and bibliographical publications, sharing the available study and tutorial literature and materials, as well as sharing information for the purpose of joint development of the new tutorial and methodological materials, course manuals, business games, educational programmes and standards;

Conducting joint scientific and practical conferences, seminars and workshops;

Arranging for videoconferences to ensure distant learning, distant solving of the problems that may arise in the course of cooperation, as well as for scientific, scientific and practical, scientific and research conferences, symposia, seminars and other events;

- Publishing research results in the form of either individual publications or edited volumes, study

guides, scientific monographs, articles, etc.;

- Upgrade qualifications of the scientists and specialists, arrange for secondment, practical and on-thejob training of the students, candidates for Master's and Doctor's degree, as well as organise the students' and professors' exchange within the framework of various programmes and events.
- 3.2. Cooperation between the Parties may assume any other agreed upon forms that contribute to performance under the present Agreement.

4. RESPONSIBILITIES OF THE PARTIES.

- 4.1. The Parties shall seek to provide maximum assistance to each other in fulfilment of the obligations assumed under this Agreement.
- 4.2. The Parties undertake to:
 - support implementation of the common projects and programmes in the manner, scope and with the
 methods set forth in separate agreements concluded between the Parties for the purpose of attaining
 the goals set in the present Agreement;

- ensure due and complete performance of all legal and actual activities required for implementation

of the common projects;

 ensure financing and conducting of various events on the basis of the separate concluded agreements in compliance with the work programmes and within the budget allocated for the mentioned events;

exchange available information resources subject to the provisions of the existing legislation;

- do not disclose the information treated by the Parties as confidential;

- organise regular discussions of the issues related to implementation of cooperation in the selected areas;
- consider the problems arising in the course of implementation of the present Agreement, make coordinated decisions in that respect.
- 4.3. The provisions of this Agreement shall not be treated as impairment of the Parties' right to carry out independent implementation of the projects, programmes, events and activities in the areas specified in this Agreement.

5. CONCLUDING PROVISIONS.

- 5.1. This Agreement becomes effective from the moment it is signed by both Parties and is concluded for indefinite term.
- 5.2. The Agreement may be modified or supplemented upon mutual agreement by the Parties. All supplements and amendments to the Agreement shall be made in writing in two copies and signed by both Parties.
- 5.3. This Agreement may be terminated upon mutual consent by the Parties.
- 5.4. Either Party has the right to terminate the Agreement by serving a three months prior notice. In this case the Agreement shall be terminated upon expiry of the three months' period following receipt by the Party of such termination notice.
- 5.5. This Agreement is made in two copies in Russian [English] language, one copy for each of the Parties.
- 5.6. For performing under the Agreement a coordinator shall be appointed by each of the Parties hetero to act under each particular assignment, which shall be specified in the appropriate supplementary agreement.

ADDITIONAL AGREEMENT

in the sphere of science and research to the Agreement on cooperation

between

"Baltic International Academy"

(Latvia)

and

Kh. Dosmukhamedov Atyrau University

(Atyrau, Kazakhstan)

signed on 21 January 2022

"Baltic International Academy" and the Non – profit joint stock company «Kh. Dosmukhamedov Atyrau University» hereinafter referred to as the Parties have hereby agreed as follows:

Article 1

The Parties, according to the existing legislation of the countries, will contribute to cooperation in the sphere of science and research based on beneficial interest.

Article 2

The Parties will contribute to the development of cooperation envisaged by Article 1 in the following spheres of science and technology:

- 2.1. fundamental and applied research in natural sciences;
- 2.2. research in the sphere of technical sciences and the development of technology;
- 2.3. research in the sphere of humanities and social sciences.

Article 3

Cooperation will be achieved by scientific and research institutions, scientific centers, departments, programmes and study directions of both Parties within the scope of their competence. The content of cooperation, both Parties will agree upon its economic, organizational and other aspects.

Article 4

Cooperation in the context of the present Additional agreement can be achieved in the following forms:

- exchange of scientific technical and scientific research information, documentation, literature and publications;
- 4.2. exchange of PhD students, scientists and researchers;
- 4.3. joint academic supervising the PhD students within the scope of their dissertations;
- 4.4. organization of science internships;
- 4.5. organization and maintenance of joint scientific and research projects and developments;
- 4.6. organization of joint seminars and scientific conferences;

- 4.7. providing possibilities for joint publications;
- 4.8. establishment of joint scientific laboratories and centers.

Article 5

- 5.1. The Parties provide protection of industrial and intellectual property rights when cooperating based on the present Additional agreement.
- 5.2. Issues on the distribution of joint results of scientific studies obtained as a result of cooperation on the basis of the present Additional agreement or questions on utilization of other information obtained as a result of scientific studies as well as questions connected with patents, copyright, protection of samples and other rights to industrial and intellectual property will be agreed upon separately in every individual case by concluding agreements between the Parties.

Article 6

In order to promote the objectives of the Additional agreement and control its implementation the Parties will appoint the coordinators responsible for specific areas of cooperation.

Article 7

- 7.1. Validity of the present Additional agreement is defined by the period of validity of the General Agreement on cooperation.
- 7.2. The Additional agreement can be amended or terminated by either Party.

A written notice of termination and modification of Additional agreement should be sent not later than 6 (six) months prior to the supposed changes.

7.3. Amendments or termination of the Additional agreement will not influence the projects earlier initiated on its basis; their implementation will be continued on the agreed conditions.

Article 8

The present Additional agreement is concluded in two original copies, each one is in English language, and both texts are of equal legal force.
